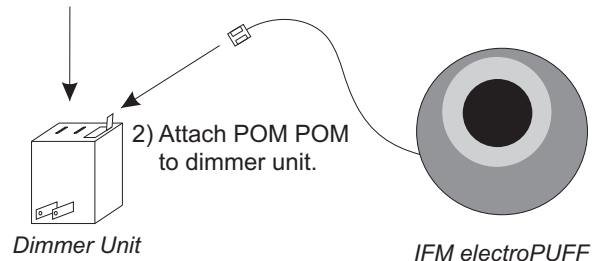
### Package Contents (IFM Part Numbers)

- 1) IFM ElectroPUFF with wire and connector
- 2) Lamp Dimmer Unit
- 3) Installation Instructions

### Installation

- 1) Plug incandescent lamp into dimmer unit.
- 2) Plug electroPUFF into dimmer unit.
- 3) Plug dimmer unit into wall.
- 4) Touch tufted sensor area to control light level on lamp.

1) Plug your lamp in here.



### Important

Use only one-way bulbs, even in a 3-way socket. Do not install this converter with a bulb or bulbs with a wattage rating over 400 watts. The electroPUFF lamp dimmer provides four levels of brightness.

### Cleaning

The IFM electroPUFF is anti-microbial and stain resistant. It requires no cleaning, however the ElectroPUFF can be sponged clean. Do not submerge in water. IFM does not recommend installation in bathroom or kitchen or other damp area. IFM's limited warranty will not cover products installed in those areas.
